Ms. Bailey reminds those in attendance that the meeting is being held remotely and is being recorded by HWCAM.

Anastasia and Steve Jewitt, 28 Burnham Road, Wenham: Mr. and Ms. Jewitt appear this evening to express their concern and frustration over the handling of the refund of their daughter's field trip to Spain. They invested \$3,000, and despite the trip being cancelled due to COVID, this money has yet to be refunded. The issue has continuously been avoided/ignored by parties they have reached out to in order to resolve this issue. The agenda this evening does not reflect this issue, though Anastasia was told it would be addressed this evening.

Ms. Banios responds to these concerns, and there is some discussion regarding the handling of these cancelled trips. Ms. Bailey ensures Mr. and Ms. Jewitt that the School Committee will vote to approve this item for a future agenda, should such action become necessary.

## C. Adopt HWRHS 2021-2022 Course Catalogue; SC Policy I9000

There is brief discussion regarding procedure and the School Committee approving curriculum changes and course catalogues. The following items are addressed through extensive discussion about the 2021/2022 Course Catalogue:

- Social Studies: credits needed for graduation, diversity of course offerings, and availability of Current American Conflicts:
- English: literature and development of a contemporary reading list to include marginalized authors:
  - There is discussion about including a more relevant and diverse reading list; current work being done by students to develop such a list; historical efforts from teaching staff to provide diverse and enriching readings; etc.;
- Math AP: availability, current virtual learning constraints, etc.;
- Athletics: marketing and women's specific sports;
- Offering/availability of climate change curriculum;
- Offering/availability of Law & Society and Civics curriculum;
- Offering/availability of Foreign language;
- Sex Education: discussion regarding medically accurate and comprehensive education and the problems inherent in Abstience Plus Education listed in the course catalgue. There is some discussion regarding inconsistencies in what is offered and what is reflected in the catalogue;
- Courses that were previously offered but are not offered in the 2021/2022 course catalogue.

## D. Presentation on Learning Management System

Mr. Wolczik provides an introduction to Dr. William Hoover, a respected author of adaptive learning technologies and online lab simulators. Dr. Hoover provides an informative overview of Learning Management Systems. He shares his screen, leading the School Committee members through the LMS

efficiencies and solutions to common remote education challenges. There is discussion about reporting, identifying at-risk students, demographics, course reporting, learning outcomes, weight assigned to outcomes, streamlining the hiring and on-boarding processes, etc.

### E. Central Office and Curriculum Organization

Superintendent Banios reviews the Central Office and Curriculum Organization, as detailed in the <u>exhibit</u>. At this point, she is not requesting any action from the School Committee, rather she seeks feedback and consensus that the district is moving in the right direction with the proposed conceptual models presented this evening. Ms. Banios notes that both of the models have been vetted by staff, teams, and through surveying.

Ms. Banios notes that the Hamilton-Wenham Regional School District has been experiencing a remarkable amount of instability over the past several years, and this instability is seen in central office and curriculum organization.

- Planning must begin now to stabilize the district and build systems that can predictably provide students with a world-class education;
- Maximize the efficiency of the Central Office to push resources to schools to support our students and teachers;
- Create a Curriculum, Instruction, and Assessment (CIA) leadership model that is informed by research;
- Value internal talent and promote teacher leadership;
- Increase communications capacity.

Mr. Polito points out that the previous LMS presentation addressed many of the concerns highlighted in Ms. Banios' presentation, and he is surprised that she had no questions or input during this time. There is discussion about how/whether LMS can provide a systematic improvement, with Ms. Banios pointing out that systems need to be developed and stabilized before implementing a LMS. The district will need higher level expertise through an external contracted HR firm.

Ms. Banios continues the presentation, noting the importance of viable instruction and teacher efficacy.

School Committee members discuss the proposed conceptual models presented this evening. There is discussion regarding LMS; district capacity; budgeting concerns; etc. There is consensus from School Committee members that the proposed plans are heading in the right direction, though Ms. Siedzik would like to see alternative options offered in the future and Mr. Wolczik requests further exploration of an LMS.

# 7. Policy

# A. Religious Observances (IMDC) second reading

Ms. Siedzik recaps the history of the Religious Observances (IMDC) policy, including previous community feedback, and the School Committee's discussions during first and second readings. Ms. Siedzik has provided the red lined changes and a clean copy of this policy. The Religious Observances policy was approved by the *Policy/Legislative Subcommittee* in a majority 2:1 vote, and is presented for the School Committee's approval this evening.

There is discussion and clarification regarding the introduction of *long term* assignments rather than introduction of *any* assignments. The language as written does not prevent teachers from introducing something new, but rather discourages introduction of new topics that may impact a student's success in longer-term projects.

# B. COVID Management Update

# a. Data reporting format

Ms. Banios reviews COVID Response Team's data reporting format, addressing issues raised through community feedback. The district is working to report a running tally.

# b. COVID Response Team Composition

Superintendent Banios explains that a parent will be added to the COVID Response Team. There is discussion regarding how the parent representative will be chosen, as well as discussion surrounding how to ensure the member abides by confidentiality agreements. There is also discussion regarding whether consideration had been given to finding a parent representative that is also a School Committee member. There is further discussion regarding the transparency of meetings, with Ms. Banios noting that making the meetings public or otherwise accessible to the public poses a great deal of risk due to the confidential data discussed. There is a brief discussion about adding a practicing physician to the team. Mr. Geary explains that the district physician, Dr. Hugh Taylor, operates under a specific scope of work, and serving on the team is not included in that scope.

## c. *K-1* anticipated return timeline

Superintendent Banios reports that the district is on track to comply with the new DESE requirements by mid-January. There is discussion regarding the formula used in calculating the number of hours reported/required by DESE. Ms. Banios explains that the hours are based on a K-12 average, and adds further details about the formula relied on. There is discussion regarding strategy moving forward, including when and how further negotiations with HWEA may become necessary. The DESE requirements for remote learning are separate from those requirements put forth for hybrid learning.

There is brief discussion surrounding the potential shift through learning models given the upcoming holidays, as well as the district's communication strategy during that time. Further discussion surrounding the DESE requirements on learning hours and the district's calculation and compliance with such requirements.
