1. Call to Order 6:00 PM

With a quorum present, Ms. Bailey calls the meeting to order at 6:03 PM. This meeting is being held remotely per emergency orders of the Governor, and recorded by HWCAM. Members in attendance are as follows: Julia Campbell, Michelle Bailey, Anna Siedzik, Dana Allara, David Polito, Michelle Horgan, and Peter Wolczik.

Ms. Bailey notes the changes to tonight's agenda: the athletic recognition will take place after the public hearing. Ms. Bailey states that the School Committee does not anticipate voting on the return to in person learning plan at the meeting this evening. However, there will be an additional School Committee meeting scheduled for next week where this item will be addressed.

2. Second Public Hearing - FY22 Budget

- A. In accordance with customary hearing procedures, statements and supporting information will be presented first by the Committee, or by others for the Committee; to comment, citizens must be recognized by the Chair, and all remarks must be addressed to the Chair and be germane to the topic.
- B. To assure that all who wish get a chance to speak, the Chair will recognize persons who have not commented previously during the hearing before recognizing persons who wish to remark a second time.

Superintendent Banios and Mr. Leone present the FY22 Budget, as presented in exhibits 1-4, as listed above. Ms. Banios addresses some of the community concerns she has heard, including the 6th grade world language program

Superintendent Banios stresses the critical nature of teaching and learning structure within the district, comparing to districts DESE has determined as comparable K-12 districts.

Shawn Farrell, Chair Hamilton Board of Selectmen: On behalf of Hamilton BOS, Mr. Farrell thanks the district for the level of collaboration and for the budget reductions presented. There is an ongoing concern about the budget increases, especially in light of the increased financial hardships from the pandemic. Mr. Farrell hopes to continue the dialogue to develop budgets and avoid overrides in the future.

Jennifer Carr, *5 Meridian Rd.*, *Wenham:* Ms. Carr is concerned about the central office administrator positions, and the perceived removal of teaching positions. Ms. Carr and Superintendent Banios discuss the restructuring of the budget, with Ms. Banios explaining that there is no reduction of classroom teachers.

There are no other comments at this time.

Public Hearing ends at approximately 6:30 PM.

Superintendent Banios recommends that citizen's comments take place now, as student athletes had planned to arrive at the meeting at 6:45 PM. There are no objections to this suggestion.

3. Citizen's Comments

Any citizen wishing to speak before the Committee shall identify himself or herself by name and address. Speakers will be allowed three (3) minutes to present their material. After Citizen's Comments, the chat feature will be turned off. If members want to be recognized, they can use the raise hand feature.

Lori Bouchard [no address provided]: Ms. Bouchard expresses her concerns regarding the timing of the return to in-person learning. She believes it would make more sense to have the return scheduled after April vacation, allowing teaching staff to receive both doses of the vaccine.

Ryan Monahan, HWRHS Football Captain: Mr. Monahan hopes the district can accommodate fans at the home and away games, as he would like his parents to attend his games. He details the various evidence that supports his request, and recommends the district lead the way in the Cape Ann League by allowing fans.

Marty Cooke, HWRHS Athlete: Mr. Cooke is here to voice his support, alongside Mr. Monahan, in encouraging the district to accommodate at least 2 fans per athlete.

Jack Mulvihill, HWRHS Athlete: Alongside Mr. Cooke and Mr. Monahan, Mr. Mulvihill appears to urge the School Committee to consider allowing fans at the sporting events.

<u>Update on Fall 2 Season</u> (originally New Business C)

Mr. Genualdo provides an update regarding the Fall 2 Season, or "wedge" season. He notes that unfortunately there were not enough partiants for cheerleading or indoor track teams. Mr. Genualdo further details the participation in this sports "wedge" season.

<u>Recognition of Winter Athletics (originally New Business B)</u>

Mr. Genualdo appears and recognizes the winter athletes and teams, as detailed in the exhibit.

There is discussion about accommodating fans at sporting events, with Mr. Genualdo explaining that there are many misconceptions surrounding this issue. He elaborates the numerous challenges, including the task of monitoring fan social distancing at sporting events. The School Committee discusses the best course of action, and what is best for students and their families. There is discussion about the language necessary in a motion to reflect the School Committee's decision.

4. New Business

A. Vote on Return to Full In-Person Learning

Superintendent Banios presents the return to full in-person learning, as presented in the <u>exhibit</u>. Ms. Banios reads a statement regarding the vaccination clinic originally scheduled for 03/13/2021, which was unfortunately cancelled as of 4:07 PM this afternoon. School Committee members express their gratitude and commend the administration for their work to secure the vaccination clinic, despite it not coming to fruition.

There is discussion regarding the in-person learning plan, including the results of the family survey; pooled testing; availability of full in person or full hybrid learning; guidance from DESE; etc. Ms. Banios hopes to have the MOA completed by 03/17/2021 and outlines the timeline planned for numerous other important dates and deadlines, including pool testing implementation and Q&A sessions with school principals.

Nurse Ting offers further details regarding the safety surrounding the return to in-person learning and the mechanics of pool testing. There is further discussion about the importance of pool testing and uniting as a community. There is a lengthy discussion regarding the details of the proposed plan.

THIS AMOUNT INCLUDES GENERAL FUND OPERATING EXPENSES (AFTER OFFSETS) IN THE AMOUNT OF \$36,934,892 AND GENERAL FUND DEBT SERVICE EXPENSES IN THE AMOUNT OF \$575,494. FURTHERMORE, THE GROSS OPERATING EXPENSES OF THE DISTRICT (BEFORE OFFSETS) IN THE AMOUNT OF \$38,738,975 HAVE BEEN ALLOCATED TO THE DESE DEFINED CHART OF ACCOUNTS ACCORDING TO THE "SUMMARY BY DESE CATEGORY" CHART INCLUDED IN THIS BUDGET PRESENTATION DATED 03/10/2021.
